MINUTES OF MEETING - September 12, 2023

Mayor Charles G. McLaurin, Council Members: Kimberly McPhail, J. Lawrence Buffaloe, Bruce R. Sykes, Cheryl C. Hudson, and M. Stan Crumpler attended the September 12, 2023, Eastover Town Council Meeting. Council Member C. Brian Pearce was absent from the meeting. A quorum was present at the Town Council Meeting. Also, in attendance were Mr. Donald Hudson, Town Attorney, Mr. Ronald Autry, Town Administrator and Ms. Elizabeth S. Bass, Town Clerk.

I. CALL TO ORDER:

Mayor Charles McLaurin called the September 12, 2023, Eastover Town Council meeting to order at 7:00 p.m. and welcomed all in attendance.

Agenda Item #1:

Town Cameras

Cumberland County Sheriff Department would have to be agreeable because once the information is gathered the department would have to assemble the information.

Stage Rental Requirements

Mr. Ronald Autry stated that the community is inquiring about renting the stage. He said that guidelines needed to be set to start renting the stage. The Council also needs to decide if the Town's sound system can be used for people renting the stage.

Agenda Item #4:

Split-Rail Fence at Park

Mr. Autry stated that he has received 3 bids for the Fencing to enclose the back parking lot. The are as follows:

- Seegars-\$7,145.00
- Professional-\$8,400.00
- R&K-\$7,227.05

After a brief discussion, Mayor McLaurin asked for a vote to approve one of the 3 bids received. Council Member Stan Crumpler made a motion to approve R&K Fencing for the project. Council Member Cheryl Hudson 2nd the motion. The vote was 6-0 for approval.

VII. <u>RECEIVE MAYOR'S UPDATE:</u>

- Need to speak with ESD (Eastover Sanitary District) about getting sewer to tranquil acres
- Metronet is scheduled to start putting lines in around September/October 2024
- Pickle Ball courts need to be moved, need to look at adding more courts
- The Newly acquired property needs to either be added to the ballpark for zoning purposes or the zoning will need to be changed
- Community Watch needs 4 magnetic signs for vehicles. They also need yard signs with heavy duty posts. The Council agreed to purchase these items.

VIII. RECEIVE TOWN COUNCIL UPDATE.

- A comprehensive study needs to be completed for the Town of Eastover. FAMPO
 (Fayetteville Area Metropolitan Planning Organization) has stated that they have
 various Federal and State funds available. A comprehensive study will allow the
 town to be able to apply for this funding
- A no soliciting policy needs to be established for the Town

 The speed of vehicles on Beard Road, Hwy 301/Dunn Road, and Middle Road seems to be out of control. The Council would like to reduce the speed limit from 45 to 35. The Town would also like to get a radar speed sign
